RECROSS EXAMINATION

QUESTIONS BY MR. REAVES:

Q Mr. Shulak, you took pretty good care of that truck while you owned it?

A Yes, sir.

Q You don't know what kind of care Mr. Melendez took of that truck after you sold it?

A No, sir.

MR. REAVES: No further

questions.

MR. FEAZELL: May this witness

be excused?

MR. VANCE: No objections.

THE COURT: All right, Mr. Shulak, you are finally excused. You can go back to Waco.

(Witness excused.)

MR. FEAZELL: The State calls

Ronda Sulak.

R O N D A S U L A K, called as a witness on behalf of the State, having been duly sworn, testified as follows:

DIRECT EXAMINATION

QUESTIONS BY MR. FEAZELL:

Q How are you doing, Mrs. Sulak?

- 1 A Fine.
- 2 Q Your name is Ronda Sulak?
- 3 A Yes, it is.
- 4 Q Spell your last name.
- 5 A S-u-l-a-k.
- 6 Q And Ronda, R-o-n-d-a?
- 7 A Yes, sir.
- 8 Q Okay, ma'am, are you married to Richard Sulak who
- 9 just testified?
- 10 A Yes, I am.
- 11 Q Were you married to Richard back in July of 1982?
- 12 A Yes.
- 13 Q Ma'am, did you meet a man named Gilbert Fajardo or
- 14 Gilbert Melendez on that day?
- 15 A Yes, I did.
- 16 Q Well, what day was it?
- 17 A July 3rd.
- 18 Q Okay.
- 19 MR. REAVES: Your Honor, we
- 20 will object to this testimony. It is repetitive.
- 21 We have already heard it from
- 22 her husband, and it is an attempt to bolster him
- 23 and his testimony before he -- he hasn't even been
- 24 impeached.
- 25 THE COURT: Well, I don't know

1 exactly what she is going to testify to yet,
2 Mr. Reaves. Mr. Feazell, what is going to be the
3 nature of this testimony? Will it be --

4 MR. FEAZELL: Basically,
5 Your Honor, that Mr. Melendez came over to the house,
6 that he did wait in the front yard with Mrs. Sulak.

7 THE COURT: Go ahead, objection
8 overruled, but avoid duplicitous questions as to
9 her husband.

10 MR. FEAZELL: I will, Your Honor.

11 Q How is it that you came to meet him?

12 A Well, Rick had placed an ad in the paper to sell
13 his truck, and he phoned me, and Rick was working
14 that day, 8:00 to 4:00, and he called.

15 I said, Rick would be coming home from work
16 that afternoon, and he came over.

17 Rick hadn't made it home yet. So we waited out
18 in the front yard for Rick. He arrived a few minutes
19 later.

20 Q Okay, and then after that, what did you observe
21 Mr. Melendez do?

22 A He got in the truck and drove around for about 15
23 minutes. I guess, test drove it, and then he came
24 back, and him and Rick -- he took the money, and
25 he bought it.

- 1 Q All right, did you have an occasion, ma'am, sometime
2 after the truck was sold to see it again?
- 3 A Yes, I did.
- 4 Q When was that?
- 5 A It was about four weeks later.
- 6 Q And where did you see it?
- 7 A On Alexander.
- 8 Q And was it parked there?
- 9 A Yes, sir, on the corner.
- 10 Q And who were you with when you saw the truck?
- 11 A My husband, Rick.
- 12 Q And did you recognize it as the truck?
- 13 A Yes, I did.
- 14 Q Okay, about four weeks later, that would put that
15 sometime in early August?
- 16 A Yes, sir.
- 17 MR. FEAZELL: That is all,
18 Your Honor.
- 19 MR. REAVES: We don't have any
20 questions of Mrs. Sulak.
- 21 THE COURT: All right, any
22 objection to her being finally excused so her and
23 her husband can go back to work?
- 24 MR. REAVES: Defense has no
25 objection.

DIRECT EXAMINATION
